Registration Guidelines & Instructions

General Information

- Complete one registration package per studio, per convention.
- To register as an individual, the participant must be the only student from their studio attending the convention.
- Do not fax & mail registration forms as duplicate entries may result. Faxed registrations accepted only if payment is by credit card. Faxed registrations will not be used as holds for registrations en route.
- Registrations are accepted on a first come, first serve basis.
- Registration is not guaranteed until all forms & payment have been received.
- To avoid late registration fees, registrations must be received by the early registration deadlines, not postmarked.
- Registrations must be received at least one week prior to each convention to insure adequate processing time.
- Registrations will be accepted at the convention, providing space is available.
- Registration confirmations will be sent approximately two weeks prior to each convention.
- Prices are in Canadian Dollars & include applicable taxes. Refunds will not be granted.
- A \$20.00 service charge will be applied to NSF cheques.

Levels

See brochure for additional level guidelines. Both age & years of training should be used to determine level placement.

Junior - Ages 7 & up (1-3 years of training)

Students must be 7 years old as of the first day of the convention they wish to attend. Proof of age must be provided for all students who are 7 & 8 years of age.

Intermediate - Ages 12 & up (3+ years of training)

Senior - Ages 14 & up (6+ years of training)

Teacher - Studio Owners/Directors & Teachers **NEW!** Minimum 17 years of age.

Observer - Family members/guardians of convention participants

- The above level guidelines are recommendations only. Teachers should use their discretion when placing students in levels. Parents who are unsure of where to place their child should consult their teacher for a recommendation. It is recommended that students be placed in the level that will challenge them the most.
- Triple Threat Dance Convention, Inc. has the right to change a participant's level placement if necessary.
- Dancers, teachers, & studio directors/owners may not attend the convention as Observers. Strictly enforced!
- One-Day participants must call the Triple Threat office for rates & registration approval. One-day rates may not be available at all conventions.

- Teachers may be included in totals, but one-day/class participants, scholarship recipients, or Observers may not be included.
- For teachers to take advantage of discounts, all participants must be registered on the same form by the early registration deadline.

- Registrations cannot be combined from multiple cities to achieve Teacher Discounts.
- The names of all participating teachers must be included on the registration form, otherwise teacher discounts will not be honoured.
- If a teacher is a parent of a participant & the Teacher Discount is taken, the family discount may not be used.
- This discount cannot be combined with Family or Multiple City Discounts.

Family Discount

- Immediate family members may apply to receive a 10% discount on each participant's convention fees. Discount does not apply to One-Day/Class, Observer, or Future Threats fees. Proof of relationship must be included with registration form, such as birth certificate or student ID.
- This discount cannot be combined with Teacher or Multiple City Discounts.

Multiple City Discount

- After attending one convention on the 2007 fall tour at full price, receive a 25% discount on all additional conventions you attend in 2007. Discount does not apply to One-Day/Class, Observer, or Future Threats fees.
- Use separate registration forms for each convention.
- This discount cannot be combined with Teacher or Family Discounts.

Scholarship Recipients

- To use a Triple Threat tuition scholarship, please check the corresponding box along with the appropriate level box on the Convention Registration Form.
- A copy of your scholarship certificate must be sent in with registration form.
- Scholarships are non-transferable & expire on November 25, 2007. Scholarships have no cash value & are not valid towards Future Threats entries.
- Do not include scholarship recipients when determining Teacher Discounts.

Future Threats Guidelines

- All Future Threats participants must be registered for the convention.
- Prior to the early registration deadlines, all studios & individual registrants are eligible to enter one routine. Additional entries are based upon the number of dancers registered for the convention from each studio. The maximum number of entries from any one studio is three routines.

1-8 registered dancers = **one entry**

9-16 registered dancers = **two entries**

17+ registered dancers = **three entries**

NEW! One week after the early registration deadline, providing space is available, additional entries will be accepted on a first come, first serve basis. At this time, the above entry limits do not apply. All Future Threats entries must be received by 2:00 p.m. on the Saturday of the convention.

- Participants may only register for Future Threats with the same studio they are registered with for the convention.
- Future Threats is approximately 2 hours in length; therefore, there are a limited number of routines accepted. All entries are accepted on a first come, first serve basis.
- Future Threats entries must be accompanied with convention registration.
- A routine may be a group, trio, duo, or solo. Solos, duos, & trios may be no longer than 3 minutes, & groups may be no longer than 5 minutes. There is no maximum number of dancers in a group. Only one solo per dancer is allowed.
- A student's age is as of the 1st day of the convention being attended. For duos, trios, & groups, an average age should be used. Please round up to the nearest age. Remember to indicate on the registration form the age of the students performing.
- In the case that a registered teacher is entered in a routine, the routine will not be eligible for awards.
